General Statement

Paragon Roleplay ('the Community', 'we', 'our', or 'us') is committed to safeguarding the privacy and personal information of its users, visitors, and members. This Privacy Policy outlines the categories of information we collect, the purposes for which it is used, and the rights afforded to you under applicable law. This Privacy Policy applies solely to online activities occurring through our website, servers, and affiliated platforms. It does not apply to information collected offline or through any channels other than those explicitly designated by Paragon Roleplay. Consent

By accessing or using our website, servers, or affiliated platforms, you hereby consent to the terms set forth in this Privacy Policy and agree to its lawful processing of your information.

Information We Collect

The personal information that you may be asked to provide, and the reasons for such collection, will be clearly disclosed at the time of collection. Information collected may include, but is not limited to: name, email address, and contact details; internet protocol (IP) addresses, browser type, and related technical data; the contents of communications submitted to us, including messages, attachments, and account information; and information provided during registration, including login credentials and other account-related data. If you contact us directly, we may collect additional details such as your phone number or any content voluntarily shared with us.

Use of Collected Information

Information collected by Paragon Roleplay may be used for the following purposes: provide, operate, and maintain our website and services; improve, personalize, and expand functionality; understand user behavior and analyze website usage; develop and enhance new features, services, and functionality; communicate directly with you or through authorized partners, including for support, updates, promotional purposes, or community announcements; and detect, prevent, and investigate fraud or misuse.

Log Files

Paragon Roleplay follows industry-standard procedures in the use of log files. These files automatically collect technical information when visitors access our website. This may include IP addresses, browser types, Internet

Service Providers (ISPs), date and time stamps, referring or exit pages, and click metrics. Such information is not linked to any personally identifiable data. It is collected solely for analytical purposes, system administration, and demographic reporting.

CCPA Privacy Rights (California Residents)

Under the California Consumer Privacy Act (CCPA), California residents are entitled to the following rights: the right to request disclosure of the categories and specific pieces of personal data collected about them; the right to request deletion of personal data, subject to lawful exemptions; the right to request that personal data not be sold or shared with third parties; and the right to not be discriminated against for exercising their privacy rights. GDPR Data Protection Rights

Pursuant to the General Data Protection Regulation (GDPR), users located within the European Union are entitled to the following rights: Right of Access – request copies of your personal data; Right of Rectification – request correction of inaccurate or incomplete data; Right of Erasure – request deletion of your personal data under certain lawful conditions; Right to Restrict Processing – request limitation on processing of your personal data under certain conditions; Right to Object – object to the processing of your personal data where lawful grounds exist; Right to Data Portability – request transfer of your data to another controller or directly to you, where technically feasible. Requests will be handled within one month of receipt, subject to lawful verification.

Children's Privacy

Protecting the privacy of children is a priority for Paragon Roleplay. We do not knowingly collect personal information from children under the age of thirteen (13). If a parent or guardian becomes aware that their child has provided such information, they are urged to contact us immediately. Upon verification, we shall expeditiously remove the data from our records.
